1.4 The school day	SchoolCloud purchased to support virtual parental meetings with parents as necessary Term 2/3. It has been used for Y7 and 11 and we be utilise for the remainder of school year. The start and end of the school day create risks of breaching social distancing guidelines – year group 'bubbles'	The school is divided into zones and students are separated throughout the day. The number of entrances and exits to be used is maximised. Different entrances/exits are used for different groups. Main entrance (A) for Y7, 10 and 8.
